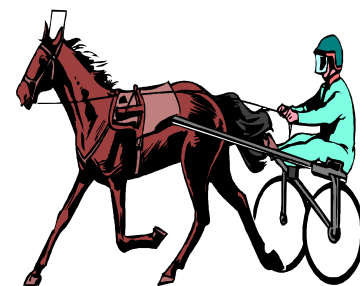

CONDITIONS

1. The USTA Rules to govern with exceptions.
2. Entrance fees: \$100.
 - A. Overnight entry fee is \$25.
3. Five to enter and four to start. Two or more horses from the same stable may start.
4. Five monies: 45-25-15-10-5 percent. One heat plan.
5. Entries and starters must be declared by 11:00 am three days preceding race.
6. Right reserved to postpone, declare off or change program, for any cause.
7. For races not filled, overnight events substituted to accommodate horses on the grounds.
8. Association assumes no liability for accidents on the grounds.
9. If in any race, more entries are received than we are able to score in two tiers, we reserve the right to race elimination heats without adding.
10. We score 5 horses with 2 trailers. Races split on 8. No more than 7 horses per field.
11. Rules of Home Talent Colt Circuit to govern Stake Races and Survivor Series.
12. 1st Place monies held until Negative Test is received from State Lab.
13. Limited Stall Space - be prepared to race out of trailer.
14. All drivers, trainers and owners are encouraged to be members of the O.H.H.A.
